Overview of Linear Open Space and Corridors



Linear open space and corridors typically are long and narrow connected land parcels that often include pathways which support walking and cycling. They may follow natural creeks, railway corridors or be linked to natural settings. They also provide for the management of stormwater catchment areas.

Council's network of linear parks offers the community opportunity to participate in passive or active recreation. These corridors of green open spaces establish a connection between urban development and adjoining natural creek lines, public recreation areas, local businesses and community services and surrounding road and rail networks.

Connected open space corridors enhance the quality and aesthetics of open spaces with protection and enhancement of the natural biodiversity.

Purpose for Which the Land is Held

Linear open space and corridors are provided for one or more of the following purposes:

- Provide accessible open spaces for the use, enjoyment and benefit of the community.
- To provide for the management of natural creeks and stormwater flows in a manner that is environmentally sensitive, minimises the risk of flooding, improves amenity and includes passive, recreational and leisure opportunities.
- To protect and enhance locally native flora and fauna.
- To facilitate the use of the land for essential utilities and services.

Management Proposals for the Land

Council will manage development and maintenance of linear open space and corridors in accordance with all legislative requirements and Council's strategic documents which include the Strategic Plan, city-wide strategies, the Asset Management Plan and applicable masterplans.

Council's strategic documents are updated periodically. They provide guidance for the planning, management and decision making for Council's community land. A full reference list of the legislative requirements and strategic framework documents is contained within the Community Land Management Plans Overview.

Any proposals which are identified for any of the linear open space and corridors are subject to Council approval and available funding (external grant funding or Council financed).

Council's key strategic management objectives for linear open space and corridors include:

- Adoption of the linear open space and corridor's vision and principles as outlined in Council's Open Space Strategy.
- Provision and maintenance of diverse and quality open space.
- Retain, protect and enhance the natural landscape as per Council's Biodiversity Directions Report 2021.

- Undertake sustainable and efficient management practices.
- The Asset Management Plan which identifies strategies to improve management practices that will deliver assets that serve our current and future community.

Description of the Land

Within this plan a table will be included which will provide the following information:

- Name of land
- Street address
- Certificate of title, plan and allotment
- Owner of the land
- Dual category CLMP number
- Crown land trust or dedication granting the City of Playford as custodians.

There may be occasions where a land parcel has been assigned multiple community land categories, referred to as “dual categories”. For example, the land parcel could have a dual purpose of a linear corridor and also a drainage function, in these instances the land parcel would appear in both the Linear Open Space and Corridor and Drainage Reserve CLMPs. The table contained within this plan will indicate where there are dual categories for land parcels.

Further information including lease and licence details for land parcels are referenced in the Community Land Register available on the City of Playford website.

Leasing, Licensing & Permits

General information regarding Council granting of a lease, licence and casual hire permits over community land is contained within the Community Land Management Plans Overview.

Lease, licence or permit agreements may be granted which are consistent with this Plan. In the case of Crown Land, the agreement must also be consistent with the dedicated purpose of the land.

Granting of a lease, licence or permit, as per the conditions set out in Section 200 and 202 of the *Local Government Act 1999*, approves the use of linear open space and corridors, by clubs, community groups, schools, commercial/private organisations or community members.

Details of current lease or licence agreements are included in the Community Land Register available on Council’s website.

Overview of Linear Open Space and Corridors



The following types of agreements may be granted over linear open space and corridors:

Licence Agreement

A licence agreement (non-exclusive) may be granted which is consistent with the purpose of the land set out in this plan for community or commercial use.

Casual Hire Permit

A casual hire permit is used for single use or short-term use and the hirer must comply with the specific terms and conditions. The issuing of a permit would be usually associated with a park or reserve located within an area of Linear Open Space and Corridor.

Objectives, Targets and Performance Measurement

Council is required within Community Land Management Plans to set out its vision for the land through objectives and performance targets, and how Council proposes to measure its performance against its objectives and targets.

Appendix A sets out the objectives, performance targets and measures for Linear Open Space and Corridors.
