1. What we asked

Council is committed to open, transparent and informed decision-making. We encourage our community to attend and participate in Council meetings and to access meeting documents to learn about the decisions Council makes on their behalf.

To support this, Council has a **Code of Practice for Public Access to Meetings and Meeting Documents** that outlines how our community can access meetings and documents, and when access to this information might be restricted due to confidentiality.

A review of the Code of Practice for Public Access to Meetings and Meeting Documents was conducted recently with some minor changes recommended.

The community were then invited to provide feedback to assist Council finalising the Code of Practice in April – May 2023.

Review and adoption of the Code of Practice for Access to Meetings and Meeting Documents is a legislative requirement under the Local Government Act 1999.

Community engagement level:

Consult: Consult the community and seek their feedback on specific options or ideas.

The objectives of community consultation were:

- Inform and educate the community on the Code of Practice for Public access to meetings and meeting documents.
- Consult the community by providing the opportunity to share their views and level of support on the Code of Practice



Additional feedback

Q: Do you have any additional feedback on the proposed Code of Practice for Public Access to Meetings and Meeting Documents

One respondent provided the following comment

"The council are dealing with funds collected from members of the council area. They should not have the right to exclude rate payers (who they work for) from any meetings".

Council and committees may hold meetings in confidence under the Local Government Act 1999, Part 3 – 90 Meetings to be held in public except in special circumstances. Notice on why a matter is considered confidential is provided to the community.

4. Next Steps

Council to review community feedback at an Ordinary Council meeting on 27 June 2023 prior to endorsement. Following the Council meeting, we will provide further information on Playford Engagement Hub.

Following Council endorsement, the Code of Practice will be published on Council's website.




